**Subject :** *Terms for re-election and reconfirmation of NRs*

**PROPOSAL 1**

**Change in bylaws :** 4.3.3

**What is the current situation ?**

NRs may be re-elected for consecutive terms of service, subject to normal election procedures.

**What is your proposal ?**

An NR may be re-elected for one consecutive term of service, subject to normal election procedures. It is the responsibility of the NR to nurture and support a suitable colleague to succeed them in their role.

**PROPOSAL 2**

**Change in the Task force Manual :** *section National representatives*

**What is the current situation ?**

There is no written for minimum requirement for NRs to be reconfirmed or re-elected.

**What is your proposal ?**

to add under the section for minimum requirements of a NR the following section:

Minimum requirements for reconfirmation and re-election for a NR :

1. An NR can only be reconfirmed if they have attended at least 3 NR or Task Force meetings during the year and submitted the annual report on time.
2. An NR can only be re-elected for a second term if they have attended at least one AGM in person or two AGMs online during their four-year term and they meet the requirements for re-confirmation each year.

**Give an overview of your arguments why IBF Members should vote for your proposal :**

A reorientation of the roles as NR is necessary.

IBF has many NRs who are inactive, do not fulfill the responsibilities according to the Task force Manual and are not in active contact with the IBF.

How can an NR represent the IBF if he/she is not regular direct contact with the other NRs, task force officers or the ET?

To concentrate the energy and power for the IBF it would be better to have fewer NRs who are active for it. Furthermore, this proposal prevents people from being given the title and role of NR and then only using this status for their own image and purposes.
